## GENERAL RULES FOR OPEN CLASS EXHIBITORS

- 1) Entry Times: ALL exhibits entered at the Fair Building between Noon and 6:00 pm on Wednesday, October 18, 2023.
- 2) Release Times: ALL exhibits will be released between 9:00 am and 11:00 am on Saturday, October 21, 2023.
- 3) Exhibitors are not restricted to Walsh County addresses; anyone is eligible to exhibit in the Open Classes, Art and Photography Show.
- 4) All exhibits must have been produced during 2022-2023, except otherwise noted.
- 5) Entries may be brought to the Fair or they may be mailed, postpaid, to the Walsh County Extension Office, 101 County Road 12B Park River, ND 58270.
- 6) Exhibits must be exhibited in LOTS where they belong.
- 7) Premiums and ribbons will be awarded only on worthy exhibits and competitive classes.
- 8) The Fair Management reserves the right; and has instructed all Division Chairman and Judges to reject any or all exhibits which are improperly represented, exhibited or otherwise undesirable with respect to the quality, variety, or lack suitable competition to be declared champion exhibit.
- 9) The Fair Management will take all available means to maintain the identity and security of all exhibits, but will assume no responsibility for exhibits lost or mixed or in any manner damaged. Exhibits will be returned at exhibitor's expense on request.
- 10) 4-H and FFA members must be enrolled in project to exhibit.
- 11) 4-H and FFA Premium lists are not included in this supplement. All 4-H families have received exhibit lists. Contact County Extension Office with additional questions.

3) 2023 crop production eligible only.

4) Only exhibits meeting size requirements will be entered.

# OPEN ART & PHOTOGRAPHY SHOW

## PREMIUMS OFFERED:

1<sup>st</sup> - \$3.00

2<sup>nd</sup> - \$2.00

3<sup>rd</sup> - \$1.00

1. All exhibits must be entered at the Walsh County Fair Building, on Wednesday, October 18, between Noon-6:00 pm. Please NOTE this is the only entry time for exhibits. Exhibits are judged at 9:00 am on Thursday, October 19. The Art Show Division area will be closed for viewing at this time
2. All exhibits must be picked up between 9:00 am-11:00 am, on Saturday, October 21. Premiums will be withheld on exhibits removed from the fair prior to Release Time.
3. All Art and Photography EXHIBITS MUST BE READY TO HANG. Eye screws and heavy wire hangings or other hanger appropriate for the weight of the exhibit are required. However, saw tooth hangers are not acceptable for hanging. If exhibit is not ready for hanging, exhibitor will be charged \$1.00 per hanger. Exhibits not ready for hanging are considered unfinished. Art Show Committee is not responsible for exhibits damaged due to being improperly hung.
4. All exhibits are the exhibitors' responsibility. The Walsh County Extension Office and the Walsh County Fair will not be held responsible for lost, stolen, or damaged exhibits.
5. Exhibits will be on display at the Fair Building during regular Fair hours.
6. All exhibits must be actual, original work of the exhibitor. The artists' work must not be a copy of another artists' work. The exhibitors must be of showmanship quality and not previously entered in competition at the Art Show. Class work items or their copies must be student's own work.
7. Three (3) entries per exhibitor are allowed in each lot for the articles that will be judged. The exhibitor may also have up to 5 additional works for display and sale in art, sculpture, woodcarving, pottery and/or photography. Exhibits in the art division are limited in size to 30" x 36", depending on availability of space.
8. Exhibitors' may sell articles, but the article cannot be dismantled until the end of the Show. Each exhibitor must handle all business transactions on the sale of the article.
9. The exhibitors' age should be written on the tags for the Junior, Youth, and Pre-Youth Divisions.
10. 4-H'ers are not allowed to compete in the Open Class Art Show with the same articles they have exhibited in the 4-H divisions.
11. In all divisions, 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place ribbons may be given on merit according to the Judges' discretion. A maximum of 1 blue, red, and white ribbon may be given per Lot in the Junior and Youth Divisions. However, all Junior and Youth Division exhibitors will receive a blue, red, white or an exhibitor ribbon.
12. Premiums are not given to the Pre-School Art Division; exhibitor will receive a participation ribbon.
13. A "Division Champion" ribbon will be given in each Art and Photography Division. An Overall "Judges Choice" Sweepstake ribbon will also be given. In case of a blue ribbon tie in a Division, red and white ribbons will be counted.
14. A protest made against any entry or against any decision of the Judges' must be made in writing within 24 hours. All protests must be made to the Art Show Committee. The protest must state plainly the cause of complaint or appeal, with specific charges and facts. All questions in dispute or differences not covered by these rules shall be referred to the governing Walsh County Fair Board whose decisions shall be final.

- 2) Exhibitors may have 3 entries per category (i.e. 3 portraits, 3 scenic, etc.)
- 3) Prints may be cropped to improve the composition.
- 4) Enlarging need not be the work of the exhibitor.
- 5) White borders on prints are to be removed.
- 6) Captions, if used, are not to exceed five (5) words and are to be placed in lower left hand corner.
- 7) Matting your prints is recommended. No glass frames.
- 8) All exhibits that do not have hangers will be hung using binder clips. Art Show Committee is not responsible for exhibits damaged due to being improperly hung.

# OPEN CLASS HOME ECONOMICS

## 1) PREMIUMS OFFERED:

1<sup>st</sup> - \$3.00      2<sup>nd</sup> - \$2.00      3<sup>rd</sup> - \$1.00

- 2) All exhibits must have been actual work of the exhibitor and have been made or finished since November 1, 2021. All exhibits must be of showmanship quality.
- 3) Exhibits must be removed between 9:00 am and 11:00 am on Saturday, October 22. Premiums will be withheld on exhibits removed from the Fair prior to the proper check out time.
- 4) All exhibits must be entered between Noon and 6:00 pm on Wednesday, October 19 at the Walsh County Fair Building. Please note: Exhibits will not be accepted at any other time. Exhibits are judged at 8:30 am on Thursday, October 20. The Home Economic Division Area will be closed for viewing at this time.
- 5) Exhibitors are not restricted to a Walsh County address. Anyone is eligible to exhibit.
- 6) Only one (1) entry per exhibitor is allowed in each LOT. LOT numbers should be attached to article or exhibit by exhibitors before entry. Official tags will be attached at time of entry.
- 7) 4-H'ers' are not allowed to compete in the open class with the same article which they have exhibited in the 4-H Division. However, they may compete in the Open Division LOTS.
- 8) The management reserves the right and Judges' are authorized to reject any exhibits which are improperly represented, exhibited or otherwise undesirable with respect to variety or quality. If there is only one exhibit in the LOT, the prize is left to the Judge's discretion.
- 9) Anyone who has never entered an exhibit at the Fair, or has not exhibited in that Division within the last five (5) years is considered a New Exhibitor.
- 10) No entry will be accepted unless there is a LOT for it.
- 11) The Junior Division is open to Boys and Girls through 18 years of age. Exhibitors' age is to be included on exhibits entered in the Junior Division.
- 12) Disabled Citizen Division is open to anyone who has any physical or mental disability.
- 13) All exhibits must be neat and clean.
  - a. Garments may have been worn, but should be clean and well-pressed. If garments need to be hung, exhibitor must provide a hanger. If a commercial pattern is used; the pattern guide is required and should be pinned to the garment, and if any changes in the pattern are made, please indicate this on the guide.
  - b. Framing is recommended but not required for all counted cross-stitch pieces.
  - c. Crocheted doilies must be fastened to a solid colored paper or cloth for exhibiting.
  - d. Food items should be displayed on a sturdy paper plate and placed in a plastic bag. The recipe is required and should be attached securely to food item.
  - e. Models should be exhibited with the directions that came with the model when the model was purchased, or if that is not possible, a note card with the steps used to assemble the model is acceptable.

- f. It is acceptable to exhibit quilts that have been constructed by the exhibitor, but have been commercially quilted.
  - g. All items must be presented in the Ziploc Bag.
- 14) Food from the same batch cannot be exhibited by more than one family member in the same LOT.
- 15) Box mixes will not be accepted as any baked food. Except for LOT 374 and 497.
- 16) All canned foods must be exhibited in a standard half-pint, pint or a standard quart jar. Jelly can be shown in standard canning jars with two-part lids and no paraffin. All canned foods are to be exhibited with screw bands left on the jars for safety in handling. Entries must be labeled with the name of the product, canning method used, and length of processing time. Wine may be exhibited in appropriate containers following recommended wine making process.
- 17) A maximum of 1 blue, red, and white ribbon may be given per LOT, according to the Judge's discretion in all Divisions. This applies to Needlework, Clothing, Crafts, Plants, Baked Foods, Canned Foods, Senior, Junior, and Disabled Citizens Divisions.
- 18) "Best of the Division" may be given to the exhibits, according to the Judge's discretion.
- 19) The Walsh County Extension Office and the Walsh County Fair Association will not be held responsible for lost or stolen articles.
- 20) All protests made against any entry or against any decision of the Judges must be made in writing within 24 hours. All protests must be made to the Open Class Committee. Protest must state plainly the cause of complaint or appeal, with specific charges and recital of facts relied upon or made. All questions in dispute or differences not covered by these rules shall be referred to the governing county fair committee whose decisions shall be final. Any ungentlemanly conduct toward the Judges or Management by Exhibitors will be cause for withholding any premium award. The decision of the Management on all matters shall be final.
- 21) Please Note: Items exhibited in the Other LOTS must not be duplicates of previous LOTS in the Division.

## **NEW EXHIBITOR AWARD**

The New Exhibitor receiving the most Blue ribbons in the Canned Foods, Baked Foods, Needlework, Clothing, Crafts/Plants, Junior, Senior Citizen Division and Disabled Citizen Divisions will each receive a New Exhibitor Ribbon. Be sure to state that you are a New Exhibitor when entering exhibits.

## **SWEEPSTAKES**

A \$25.00 cash award will be given by the Walsh County Fair Association to each of the individuals receiving the greatest number of Blue ribbons in each of the following Divisions, Canned Foods, Baked Foods, Needlework, Clothing, Crafts/Plants, Junior, Senior Citizen Division and Disabled Citizen Divisions. In the event of a tie, the Sweepstakes winner is selected on "Best of the Division" or top entry exhibits.

No one person will be awarded a Sweepstakes in any one Division of the Open Home Economic areas for more than two (2) years in succession.
